# The Problem

- 350,000 unserved locations (new estimate to be released soon)
- Primary problem is the economics of the infrastructure to serve these areas
- Impetus to solve the problem comes from many angles
  - Economic
  - Social/political
  - Moral
- Governor set bold goal of universal access by 2028
- **\$124 million** has been awarded since 2017, connecting **140,895** homes, businesses, and community anchors to broadband.

# Economic Impact

- According to an Amazon/US Chamber of Commerce Study, increased connectivity will impact Virginia's rural economic growth tremendously. They estimate:
  - **\$2.24 billion** increased annual sales
  - **\$1.29 billion** annual value added
  - **9,415** added jobs
  - **\$452.4** million in annual wages
- According to a 2019 USDA study, if broadband and precision agriculture tools were ubiquitous, the U.S. could realize economic benefits of 18 percent of total production. For Virginia, 18% would be equivalent to a **\$16.3 billion increase in VA Agriculture and Forestry output.**

# State Grant Programs

- Department of Housing and Community Development - Virginia Telecommunication Initiative (VATI)
- Tobacco Region Revitalization Commission – Regional Economic Development Program
- Community Development Block Grant Planning Grant (CDBG)
- Department of Housing and Community Development – GO Virginia (middle mile)
- Appalachian Regional Commission (ARC)



# Grant Programs: VATI

- Provide financial assistance to supplement construction costs to extend services to areas unserved by any broadband provider.
- “Unserved” is defined as having access to broadband speeds of 25Mbps per second download/3Mbps per second upload or less
- Applicant must be a unit of local government

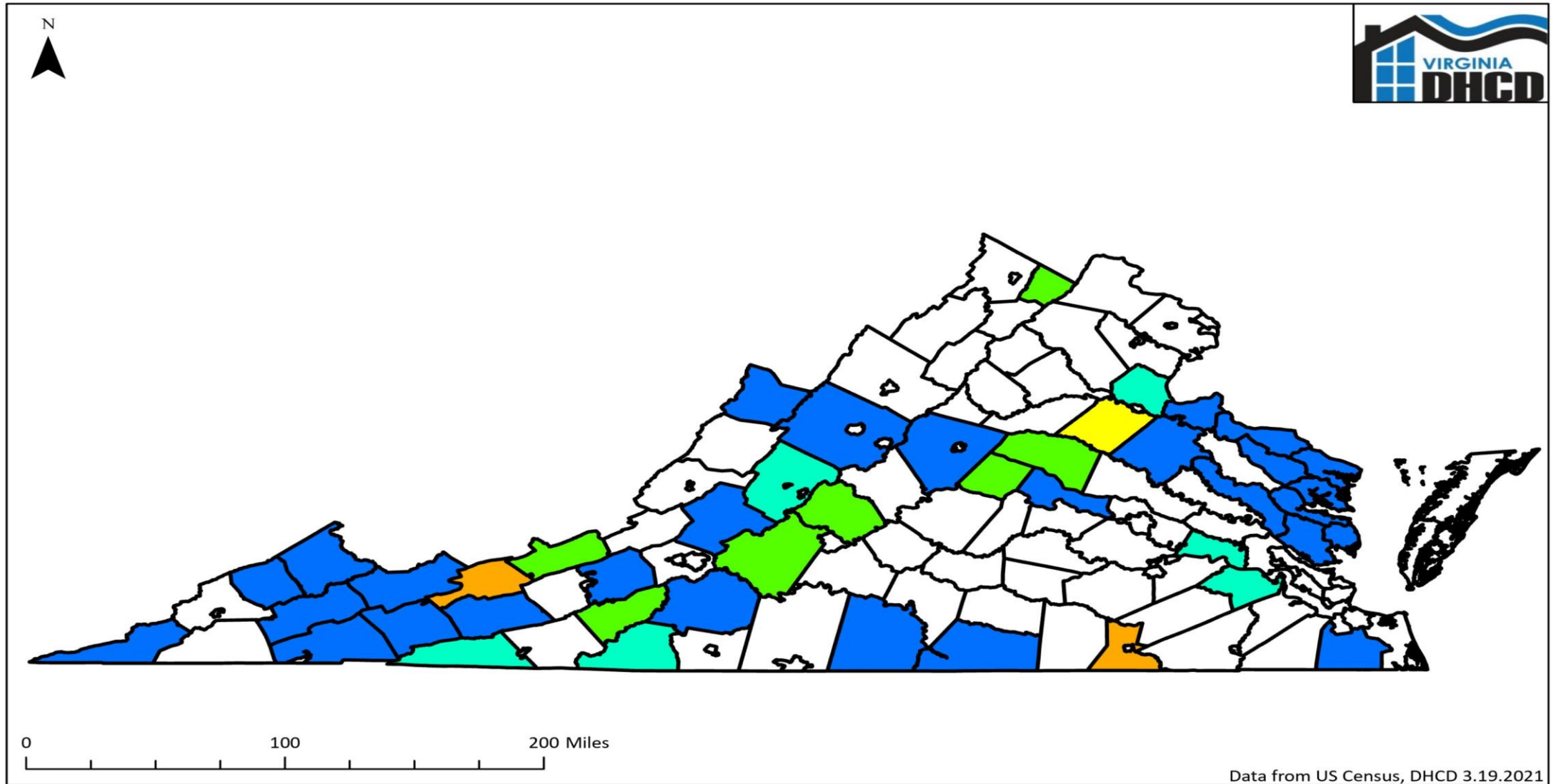


# Grant Programs: VATI

- \$30 million allocated for broadband connectivity in October 2020
- Shenandoah Valley Localities:
  - Page County - \$2.1m (2 projects)
  - Augusta County - \$900k (3 projects)
  - Rockbridge County - \$770k

# Upcoming Federal Resources

- **Coronavirus Capital Projects Fund**
  - “To carry out critical capital projects directly enabling work, education, and health monitoring, including remote options, in response to the public health emergency with respect to COVID-19”
  - VA is estimated to received \$220 million
- **Direct Funding to Virginia and Virginia Localities**
  - \$3.7 billion for Virginia, \$2.8 billion for localities
- **Emergency Broadband Benefit Program**
  - \$50/month subsidy for low-income households for the cost of broadband services for 6 months
  - Program launches at the end of April, not all providers are participating

# Broadband Legislation

## SB 1413/HB 2304

- Makes permanent the utility leverage pilot program, permitting Dominion Energy and Appalachian Power to build and lease excess fiber (middle mile networks) to ISPs during grid modernization.
- Adding more middle-mile fiber throughout the state has increased competition and improved economics for ISPs.
- Program has facilitated universal broadband coverage in Grayson, Surry, Northumberland, Westmoreland, Richmond, and King George counties. At least a dozen additional universal projects are in the works.
